RP, EU eye cooperation pact

MANILA – The Philippines and the European Commission (EC) will start negotiations to draft a cooperation agreement that will serve as the framework of relations between the country and the European Union (EU), Malacañang said October 24.

The decision was reached during a meeting between President Gloria Macapagal-Arroyo and EC President Jose Manuel Barroso in Beijing on Friday, on the sidelines of the 7th Asia-Europe Meeting, the Palace said in a statement.

“President Arroyo emphasized that the cooperation agreement would not only benefit Philippine trade in Europe, but would open wide opportunities for greater cooperation,” the statement said. “Both leaders expressed satisfaction on the level of relations between the Philippines and the EU, and look forward to a more enhanced collaboration that the partnership agreement would offer,” it said.

The EC is the executive branch of the 27-member European Union. ■

BI can't say if Bolante arriving Oct. 28

MANILA – The Bureau of Immigration said on Oct. 24 it could not confirm reports that former agriculture undersecretary Jocelyn “Jocjoc” Bolante will arrive in Manila on Tuesday, October 28.

Bolante, who is accused of funneling P728 million worth of agriculture funds to the President’s campaign kitty in the 2004 elections, is expected to be deported from the United States after his bid for asylum was rejected.

Unofficial reports say Bolante, who evaded congressional investigation on the fertilizer fund scam by flying to the US in 2004, will arrive in Manila on Tuesday, October 28, via a Northwest Airlines flight.

Ferdinand Sampol, the immigration supervisor at the Ninoy

Aquino International Airport, said he had yet to receive information from the United States government about Bolante’s arrival.

“We are wondering about it. Commissioner [Marcelino] Libanan was interviewed on the radio and he said he doesn’t know anything yet,” Sampol said in a telephone interview.

If Bolante will indeed board Northwest Airlines flight, he will definitely land in NAI Terminal 1, Sampol said. “Northwest’s has landing rights on Terminal 1,” he explained.

When he arrives in Manila, Bolante, who will be escorted by US marshalls, will have to file interception forms and have his travel papers stamped.

He will then be turned over to the authorities, Sampol said. ■
