than honorably discharged. Outside the US embassy, police blocked small groups of protesters who denounced the appeal court's ruling and demanded that Manila cut military ties with Washington, its former colonial master, photographers at the scene said.

The appeals court ruled that "no evidence was presented to show force, threat and intimidation applied by the accused" on the woman.

The woman had alleged that Smith sexually assaulted her in a van while in the company of other US Marines.

Smith insisted the sex was consensual.

Last month, the woman issued a statement casting doubt on her earlier testimony.

Smith met the woman in a bar in the port of Subic, after taking part in joint US-Philippine military exercises.

The woman is reported to have left the Philippines for the United States, where she now lives with an American boyfriend whom she met after the alleged rape.
