### Is there hope after lying to get a Green Card?

the green card and deport the alien.

All is not lost. There is still hope. Immigration and Nationality Act Section 237(a)(1)(H) allows an alien who lied to obtain a green card to apply for a waiver. The waiver is available to aliens who are the spouse, parent, son or daughter of a citizen of the United States or of an alien lawfully admitted for permanent residence. In order to receive the waiver, the alien must show the positive factors

or business ties; evidence of value and service to the community; and other evidence of the alien's good character".

Under INS v. Yang, the immigration judge may consider as negative factors all the lies told in order to get and keep a green card - including the initial lies told to gain entry into the United States. That means that the judge can consider as a separate fraud the remarriage after the alien obtained the green card and the petition based on the second marriage. The judge can also consider any lies told on naturalization application as distinct and separate frauds. Each of these lies will count as a separate
