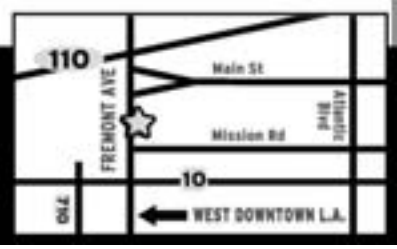

US no longer advising schools close for swine flu

ATLANTA—US health officials are no longer recommending that schools close because of swine flu. The government last week advised schools to shut down for about two weeks if there were suspected cases of swine flu. Hundreds of schools around the

country have followed that guidance and closed schools. Health and Human Services Secretary Kathleen Sebelius said Tuesday, May 5, that the swine flu virus had turned out to be milder than initially feared and the government decided to change its advice. Sebelius says

parents should still make sure to keep sick children at home. Those with flulike symptoms should stay home for seven days. The number of confirmed swine flu cases in the US is now over 400, with hundreds more probable cases. (AP)

will be in the stands. Pacquiao and Roach will be accepting their fighter of the year and trainer of the year award, respectively, that weekend but most importantly, the two will have a first hand view of Cotto as a possible match up. Bob Arum represents Cotto so discussions and contracts should be cinch. The question is if Cotto has too strong of an outing against a tough boxer like Clottey, will Roach still want Pacquiao to face the Puerto Rican?

Sugar Shane Mosley
Mosley's eyes lit up when Roach mentioned the 37-year-old's name at the post fight press conference

as one of the possible future opponents for Pacquiao. There is one catch. Mosley would have to drop to a "catch weight" of 143 or 144-pounds to fight the Filipino star. But Mosley, who had a tremendous knockout performance against Antonio Margarito to capture the WBA Welterweight Title just a few months ago, knows his time in the boxing ring is running out. He wants one or two more major fights before he calls it a career. Expect Mosley to push hard Golden Boy executives for a fight with Pacquiao, perhaps even willing to accept lesser money to do it. ■

in the Philippines but lost, in part because voters thought he could do more for the country as an inspirational champion boxer. I agree with the Filipino people," Lewis said in the article.

Pacquiao, a native of General Santos City, ran and lost to South Cotabato Representative Darlene Antonino-Custodio (first district) in the 2007 elections. Pacquiao, in a recent CNN interview, had announced that he would run for public office next year.

Pacquiao's representatives have since petitioned the Commission on Election to accredit his new political movement, "The People's Champ Movement."

News commentaries and features on the run up to the May 2 (May 3 in Manila) Las Vegas fight often referred to Lewis' comment about Pacquiao's presidential future without crediting the magazine.

Both the CNN and BBC networks commented in several May 1 reports that Pacquiao had united the Philippines. The British news program also cited the fact that the fight "had emptied parliament (Congress)."

Several Philippine representatives admitted scheduling trips to Las Vegas to watch the fight.

"Pound for pound, Manny Pacquiao is the best boxer in the

world. But even more important than holding that distinction, Manny had connected with the people of his home country, the Philippines, to the point where he's almost like a god," Lewis said.

Pacquiao is featured on a spread, which features Winfrey and losing United States vice presidential candidate, Sarah Palin.

He is among 11 most influential Asians who include Indonesian President Susilo Bambang Yudhoyono, Chinese Vice Premier Wang Qishan, Chinese Vice President Xi Jinping, Chinese Internet wiz Jack Ma, Chinese musician Lang Lang, Japanese physicist and Nobel prize winner Yoichiro Nambu, Pakistani Army chief of Staff Ashfaq Kayani, Indian CEO Nandan Nilekani, Indian composer A.R. Rahman and Cambodian activist Somaly Mam.

The Time 100 list included the world's top political leaders and revolutionaries; builders and titans; artists and entertainers; and scientists and thinkers. ■
