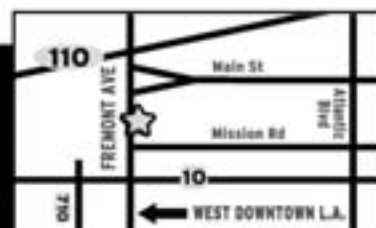

"battle for number 1" because most boxing pundits believe that the winner would most likely face off against Pacquiao at the end of the year.
Vice President and Matchmaker of Golden Boy Promotions Eric Gomez said that there's a very high likelihood that the winner of the match will face Pacquiao.
"I'd have to say very good," said Gomez. "Pacquiao is in a position right now, and he's earned it, to choose whoever he wants to fight."
Marquez and Mayweather Jr. both know the implications of a possible future bout with Pacquiao.
Pacquiao has ducked a third fight with Marquez for the past year.
The 35-year-old Marquez said it's the reason why he took the fight with Mayweather Jr.
"It's another part of motivation for me," said Marquez, who fought Pacquiao to a draw in their first bout and dropped a narrow split decision in 2008. "When Golden Boy told me, 'do you want to fight Floyd?' Yes. I want to fight with Floyd. 'And now tell me if you win this fight then maybe you fight with

Manny.' It's another motivation for me."
Mayweather Jr. said Pacquiao is a good fighter but that's not his primary motivation from coming out of retirement.
He said that he just wants to stay undefeated and fight the best.
"I don't have to chase no fighter," said the 32-year-old Mayweather Jr., who is coming off a nearly two-year retirement from boxing. "We all know that when fighters face Floyd Mayweather they make their biggest paydays. I'm not here to chase fighters I'm not here for bragging rights. I'm here to just come to this sport and to put some extras on and solidify my legacy and pound for pound [legacy]...of course, I'm going down in the history as one of the bests but I want to put a little bit of extras on."
No matter who wins the July 18 clash between Mayweather Jr. and Marquez, expect Pacquiao to be waiting in the wings.
Tickets for the July 18 Mayweather Jr. and Marquez bout will be on sale on Friday, May 22. Ticket will be available in all ticketmaster locations. ■

NV officials want more people to visit...

The senator noted that Las Vegas has over 10 million square feet of convention space, nearly 2,000 restaurants, 140,000 rooms, with 13,000 more scheduled to open this year.
"Almost 1,000 flights come and go into and out of Las Vegas each day and McCarran International Airport connects directly to 132 cities across America and around the world," he said.
"Nowhere else will you find the amenities, service, convenience and value that our hotels and convention centers offer," he added during the senate committee meeting last May 13.
Sen. Reid's statement came as he discussed the importance of tourism to Nevada, as well as his efforts in Congress to boost tourism around the country.
Nevada has been suffering from lackluster tourist visits since the start of the year, due to the sagging national and global economy.
In Las Vegas alone, visitor volume dwindled by 8.7% from January to March this year, compared

to the same period last year. Convention attendance, meanwhile, dropped by almost 30% during the same period, data from the Las Vegas Conventions and Visitors Authority showed.
This has been a problem for Las Vegas residents who work in the hotel and casino industry that has been implementing persistent massive layoffs since last year.
MGM Mirage, Nevada's largest employer, has reduced its full-time workforce by more than 1,000 in Nevada over the past year, and Harrah's Entertainment, the world's largest gaming company, has laid off about 2,000 workers in the state since January.
"The recent decline in visitors to Nevada has unfortunately contributed to the worst state budget shortfall in the state's history," Sen. Reid said during the May 13 senate hearing.
For this reason, the local government in Nevada has been pushing for increased promotions for tourists and business conventions alike.
"Simply put, our state depends on visitors. The more who come and enjoy our state, the better off is Nevada," Sen. Reid added.
Nevada is also expected to improve tourism performance with the appointment of veteran marketing professional Dann Lewis as director of the Nevada Commission on Tourism (NCOT).
"With the present economic conditions, we urgently need more tourists to visit Nevada," Governor Gibbons said in a statement released May 12.
"I believe Mr. Lewis' experience and ideas are key attributes that will help him bring effective leadership to the NCOT," he added.
Lewis has been in the tourism and hospitality business for more than 40 years. Prior to being appointed NCOT director, he was did a research project for Maine Department of Transportation and made policy recommendations on tourism-related activities within the department.
He was acting-Commissioner and Director of Tourism for the Maine Department of Economic and Community Development.
As Director of Tourism of the New York State Department of Commerce, Lewis was one of the primary marketers for the famed "I Love New York" campaign.
"Nevada's economy relies on tourism, and during this challenging economy, our hospitality industry will receive an immediate benefit from his knowledge and skills as we work together to attract more visitors and the revenue they generate," NCOT chair Brian Krollicki also said in the statement. ■
