AFAR petitions to become party list in RP

THE Association for Filipinos Abroad and their Relatives (AFAR) petitioned the Commission on Elections (COMELEC) in the Philippines for registration as a Party List. The COMELEC may grant a hearing before November this year. Under Philippine Election Laws, sectors, like the youth, poor, farmers and migrants, among others, may be represented in Congress, if said partylist gets at least 2 % of total votes. Gauging from the last elections, a partylist needs at least 400,000 to 500,000 votes to get one seat in Congress. A maximum of 3 seats may be allotted to a partylist, if it gets the required votes needed for 3 representatives.

AFAR registered to represent migrants, including Overseas Filipino Workers. This sector has no effective representation in Congress, hence AFAR is born out of the need to fight for migrants. Its programs include expanding the staff in each Embassy and Consulate around the world to keep track of all OFWs and to provide free legal and other services. OFWs work hard in foreign countries to take care of their loved ones back home. AFAR's program will also

reach out to families in the Philippines, to ensure that their health and well being is being taken cared of.

Migrants will have to do their share in order to ensure that AFAR gets to represent them. Votes count and migrants will have to register as Overseas Absentee Voter (OAV) to get a mailed-in ballot. The deadline for registration as an OAV is end of August. AFAR's website www.afar-phil.com has the OAV form and the list of Consular offices where you may mail your OAV.

Migrants in the United States, if US citizens, will have to elect first to become dual citizens. The program is also found in AFAR's website. Filipinos in the US holding Philippine passports may only register as OAVs.

So far, AFAR has a worldwide structure, with Dr. Epimaco Densing, Jr. as the World President. In order to ensure that all migrants are represented in AFAR, there are regional offices located around the world. Policies that would govern AFAR's future direction will be based on population in every region. ■

Mancao wants bulletproof vest upon arrival

MANILA – Former police colonel Cezar Mancao II requested that a bulletproof vest be put on him when he returns to the country later this week for the re-investigation of the 2000 Dacer-Corbito murders.

Justice Secretary Raul Gonzalez said on Tuesday Mancao's lawyer, Arnedo Valera, relayed his client's request for the security precaution.

"I received a call from (Mancao's lawyer) asking that he be given a bulletproof vest," Gonzalez said.

Gonzalez added that Valera and Mancao's wife, Maricar, would just follow Mancao to the Philippines instead of coming along on the same flight from the United States as initially planned.

Gonzalez said Mancao's flight for the Philippines has been booked and scheduled to arrive on Thursday.

The justice secretary said Mancao would be in the custody of the NBI upon his arrival in the country.

Gonzalez has repeatedly said that the Department of Justice (DoJ) has yet to receive any specific threat to Mancao, the government would not take his security for granted.

Gonzalez said the DoJ could give the other Dacer-Corbito accused, Glenn Dumlaog, two weeks to arrive in the country before starting a new preliminary investigation that would take in Mancao and Dumlaog's new testimonies.

The justice secretary said that Dumlaog's return would hinge on how satisfactory his deposition would be in connection with the extradition hearing of another co-accused in the case, Michael Ray Aquino, in a New Jersey court.

He said the deposition would be the only legal hurdle to Dumlaog's extradition as Dumlaog already dropped his habeas corpus case against the US authorities.

Gonzalez said he preferred that Mancao and Dumlaog be in the country before the preliminary investigation. He said he would not want to have separate proceedings for Mancao and Dumlaog's testimonies.

Mancao is a former aide of Senator Panfilo Lacson, who was chief of the Philippine National Police (PNP) when publicist Salvador Dacer and his driver Emmanuel Corbito were murdered.

Dumlaog was a former subordinate of Mancao. Lacson had denied involvement in the Dacer-Corbito case. (Inquirer.net)
