As the leader of the group, Jon Joven has extensive Broadway and off-Broadway experience for the last ten years. Jon was part of the Miss Saigon Germany production where he played Thuy. The role of Freddy Einsford Hill was given a new life by him in the US production of *My Fair Lady*. He was also part of the ensemble of the US productions of *South Pacific* and *West Side Story*. On Philippine stage, he was part of *Himala* the musical, where he played the principal role of Orly, and *Noli Me Tangere* where he played Crisostomo Ibarra. He received the first Academy Special citation for theatrical excellence from the FAMAS Awards in 2004 and was nominated Best Actor in a musical play (for *Noli Me Tangere*) at the 2005 Aliw Awards.
