The IALAG was formed by virtue of EO 463 in 2006 "for the coordination of national security cases."

"IALAG has already accomplished its mandate," the President said in her directive.

Executive Secretary Eduardo Ermita told reporters the abolition of the IALAG was upon the "recommendation" of UN Special Rapporteur Philip Alston, who visited the Philippines in 2007 to check on reports of human rights violations and extrajudicial killings in the country.

"It (EO) would show that we are responsive to his (Alston's) recommendations because he thinks this IALAG is an instrument for violation of human rights of insurgents and those identified with the insurgents such as militant groups, which is not necessarily true," Ermita said.

"But so that there would no longer be any questions the President decided 'let's just abolish IALAG'," he said.

He pointed out that IALAG is registered with the UN Human Rights Commission. ■

Filipino in crashed flight identified

MANILA – The Filipino who was among the 228 passengers of Air France Flight 447 which crashed into the Atlantic Ocean has been identified, the Department of Foreign Affairs said Tuesday afternoon.

Quoting the Philippine embassy in Paris, which was notified by the French foreign ministry, the DFA identified the Filipino fatality as Arden Jugueta, a seafarer whose vessel docked in Rio de Janeiro and who was to take a connecting flight from Paris to Manila.

In a statement, the DFA said the fatality's ship manning company also confirmed that Jugueta was on board Air France Flight 447.

The Paris main offices of Air France and the local shipping agency have also communicated with the Filipino seafarer's family.

DFA Secretary Alberto Romulo has extended the department's deepest condolences to Miguela Jugueta, the

wife of Mr. Jugueta, and his family.

The DFA said it will continue to monitor the latest developments in the ongoing search and rescue operations by military and aviation authorities of Brazil, France and Spain near the island of Fernando de Noronha, about 1,500 miles east of Rio de Janeiro.

The department said it will also extend assistance to Jugueta's family.

Air France Flight 447 crashed into the Atlantic Ocean on the evening of May 31 (Brasilia time) en route to Paris, France from the Galeao International Airport in Brazil.

Earlier, in his report to the DFA, an interim Charge d'Affaires Christopher Montero said Brazil's military and aviation authorities have sent search and rescue teams near the island of Fernando de Noronha, about 1,500 miles east of Rio de Janeiro, but have yet to find the plane and its passengers.
