an option to families who cannot afford to send their children to major cities like Legaspi or Manila for quality education. TLC has the lowest college unit cost in the country and expects an enrollment of 1,000 elementary, high school and college students this school year. "I really want it to be known as the school where our graduates are an influence of good wherever they are, well prepared in skills and are communicators. It is mandatory that they speak English—it's the lingua franca of the 21st century. It does not make them less Filipino, just more like global citizens," said Lewis in the cover story.

Offering courses in Business Administration specializing in Entrepreneurship, Information Technology and Financial Accounting, the school encourages and teaches entrepreneurial thinking and skills. "Education is the key to leaving poverty," emphasized Lewis.
