Under no circumstance should you ignore a jury summons, because if you do so, you could face possible fines and penalties through the county court system.

But, the bottom line is if you are in illegal status, you should really think about doing something so

that you could get in legal status, get a green card, eventually become a US citizen, and then you could possibly serve on a jury.
